### STATE LEVEL WORKSHOP ON SOCIAL AUDIT

### About the Workshop

A "Workshop-cum-Hands on training for Quality Social Audit" was organized by OSSAAT on 16th August 2022 at Madhusudan Das Regional Academy of Financial Management (MDRAFM), Bhubaneswar.

The workshop was organized for District Social Auditors and Block Social Auditors of Odisha. Sri. Arindam Dakua (IAS), Director Special Projects, PR & DW Department, inaugurated the Workshop. Sri.Gurjeet Singh, Mission Manager National Resource Center for Social Audit, NIRD & P.R, Hyderabad attended the workshops as Guest of Honour of the programme and Sri.Sumeet Panda, Consultant Right to Food Campaign attended the Workshop as Resource Person.

Besides, Sri Nihar Ranjan Swain, Director, OSSAAT, Sri Maheswar Swain, OAS, Addl. Secretary, P.R & D.W Deptt., Sri Trilochan Mohanty, OAS, Joint Secretary, PR & DW Department along with Sri Pradosh Kumar Das, Assistant Executive Engineer, PR& DW Department and all the Social Audit Experts of OSSAAT also attended the programme and presented their valuable suggestions and ideas on MGNREGS and Social Audit implementation.

#### Objectives of the Workshop

- To arrange a State level consultation on Quality Social Audit
- To upgrade the intensity in the process of Social audit by sharing the experiences of other states and their best practices.

#### **Observations and Suggestions**

In the workshop following observations and suggestions were documented:

- For the smooth conduct of social audit in the GPs a detailed guidelines on social audit and procedure for MGNREGS along with all other schemes for social audit shall be prepared by keeping in view the Auditing Standards and Audit of Scheme Rules, 2011.
- The vacant positions of Resource Persons needs to be filled up on the basis of empanelment and up gradation the cadre of Resource Persons from VRPs to BRPs, BRPs to DRPs and DRPs to SRPs by assessing their performance and requisite qualification for the purpose.
- As quality in social audit process is a major concern for OSSAAT, Capacity Building of Resource Persons needs to be taken up for upgrading their skills in different aspects like Community Mobilization, Strengthening of Gram Sabha, Report Writing, Social Audit process etc.
- The quality of the social audit shall be enhanced by mobilizing the community for better participation in the process of social audit through different platforms including Gram Sabha and Public Hearing.
- As viewed by National Resource Person the Social Audit team must stay at GP and Villages during the social audit process for building up better rapport with the stakeholder to deprive better outputs and outcomes from the Social Audit.
- Community vigilance mechanism is to be developed and strengthened by the social auditors for monitoring of the implementation of the schemes at Grassroots level.

### Introduction of Social Audit in Pradhan Mantri Awas Yojana-Gramin (PMAY-G)

OSSAAT has added a new initiative i.e the Social Audit of the PMAY-G scheme in the FY 2022-23 after the preliminary discussion with Sri. Kulamani Mishra, Deputy Secretary, PR& DW Department.

In this context, OSSAAT has been requested by the Department to start the Social Audit as quickly as possible. Accordingly, OSSAAT started the social audit process from the month of September 2022 in two blocks i.e Satyabadi and Kansa of Puri district.

Prior to that the Resource Persons of District and Block level were imparted training to conduct the social audit process of the scheme. From November 2022, onwards the social audit under PMAY-G was started in full fledge in 30 districts. Further the target has been set to cover the audit process in all the Gram Panchayats by March 2023.

OSSAAT also developed the Social Audit Guidelines, Formats both in English and Odia version for the acceleration of the audit process in the state.

### Regional Training to Odisha Social Justice Cell by NIRD & PR, Hyderabad under DoSJE, Govt. of India

The Department of Social Justice and Empowerment (DoSJE), Govt. of India, has taken decision to conduct Social Audit of all its Schemes to improve transparency and accountability in the programme implementation.

The department has planned for its Social Audit in a Scheme entitled Information, Monitoring, Evaluation and Social Audit (I-MESA). For this purpose National Resource Centre for Social Audit has been established under Centre of Social Audit in NIRD & PR, Hyderabad.

The training to the Resource Persons has been planned to enhance capacity of Resource Persons in Social Audit Unit to effectively





facilitate Social Audit of Schemes under DoSJE. In this context, 10 members of Social Justice Cell were nominated to attend the training to inculcate the salient features and essence of the schemes and their process of verification.

By keeping these things into account, OSSAAT has nominated ten Resource Persons to attend the Regional Training Programme on Social Audit of Schemes under DoSJE, GoI during 7th Sept to 16th Sept. 2022 in Extension Training Center, SriKalahasti, Andra Pradesh.

The programme schedule of the training program was includes the 6- days' class room/in-house orientations on different schemes under DoSJE and 3-days field visit to have an exposure on various innovative projects and practices in the field on the schemes that are taught them in the class room situation and to make them understand the verification process. organised to discuss on the social audit findings under the chairmanship of District Magistrate and all department officials. A team of Resource Persons team from Odisha has actively participated and successfully completed the 10-days training programme.

### Progress of Social Audit


- During the financial year 2022-23(1st Cycle) OSSAAT has under taken regular Social Audit of MGNREGS, NSAP, NFSA, ICDS & MAMATA & 15th CFC grants and completed successfully.
- The Annual Social Audit calendar was approved by Chairman, Executive Committee and Director, OSSAAT.
- In course of the Social Audit process, the team has verified 80% Job cards and met the entire beneficiaries at their door step.
- The Social Audit team focused on peoples' participation in Social Audit, Gram Sabha & Public Hearing and also their level of awareness about their rights and entitlements under all the aforementioned schemes.
- The Social Audit team visited all the worksites and ensure whether the assets have created as per the norms of MGNREGS.
- During the process of Social Audit, the team also ensure the proactive disclosure of all the information relating to the above mentioned scheme.
- The team also identified the ineligible beneficiaries who are getting Pension/Ration under NSAP, scheme.
- In the social audit process of NSAP, the beneficiaries who are eligible but deprived of their entitlements, they were also checked during the process.
- The social audit team visited all the work sites/assets to verify the procedural violations under 15th CFC scheme.


#### Social Audit Findings





### FOLLOW UP ACTION ON SOCIAL AUDIT FINDINGS

It was the last and very important step in Social Audit process that, after the Social Audit is completed and the findings validated in the Gram Sabha, a copy of the report is handed over to the District Administration to initiate action against the identified issues. Further the SAU resource person has responsibility to follow up the ATR in regular intervals, till the action has been taken on each reported issues to close it with satisfactory resolution.

### **ACTION TAKEN ON OTHER SCHEMES**

In other audited schemes, OSSAAT compile all the district findings report and prepare a State consolidated findings report and submit the same to State Administrative for action on Social Audit Report. The State Report for the FY 2022-23 of 15th CFC Grants NSAP and ICDS & MAMATA schemes has been complied and will be submitted shortly to State Administrative Department.

### SIGNING OF MOU BETWEEN OSSAAT AND OSEPA, S & ME DEPARTMENT, GOVT. OF ODISHA

A Memorandum of Understanding (MoU) has been signed between Sri Anupam Saha, IAS, State Project Director, Odisha School Education Programme Authority (OSEPA), S & ME Department, Govt. of Odisha and Sri.Nihar Ranjan Swain, Director, OSSAAT for conduct of Social Audit of flagship programme Samagra Sikshya on 18th November, 2022 at OSEPA conference hall.

The main purpose of the MoU is to build a formal collaboration between the OSEPA & SAU, Odisha for conducting Social Audit to enhance public accountability and its monitoring mechanism in the implementation of Samagra Shiksha at grass root level independently.

As this scheme covers pre-education to +2 level, there are many area specific and need-based issues in the process of programme implementation i.e out-of-school, dropout rate, retention, Pupil-Teacher Ratio (PTR), Child-Friendly Equipments,





Teaching-Learning Materials (TLMs), Teacher Rationalisation, Curriculum & Syllabus and so on at all level. These are purely area specific problems and they need specific interventions and hence the necessity for social audit on these themes on the implementation of the scheme in all government managed schools of Odisha under the S & ME Department, Govt. of Odisha.

The Social Audit will be completed in five years in all the schools of the State. During the Year 2022-23 it has been decided to complete Social audit in 70 blocks covering 10000 Nos. of Schools. In this regard Ministry of Education, Govt. of India has communicated comprehensive guidelines on the process of conducting the Social Audit in letter no-F.1-2/2021-IS-9 dated 26.10.2022.
